#### ORDER GRANTING EXTENSION OF TIME

Issue Date: March 13, 2017 Effective Date: March 13, 2017

On March 6, 2017, Kansas City Power & Light Company (KCP&L) and KCP&L Greater Missouri Operations Company (GMO) filed requests for an extension of time in which to file their 2017 Integrated Resource Plan (IRP) Annual Updates. KCP&L and GMO noted that their filings are due on March 15, 2017. However, KCP&L and GMO indicated that they are currently in the final stages of preparing a Demand-Side Management (DSM) market potential study expected to be completed in the first week of April 2017. Therefore, KCP&L and GMO request that they be granted extensions of time until June 1, 2017 to file their 2017 IRP updates with stakeholder meetings to be held 20 to 30 days later.

Commission rule 4CSR 240-22.080(15) provides that the Commission "may extend or reduce any of the time periods specified in [the IRP] rule for good cause shown." KCP&L and GMO stated that the use of the most current information, specifically the expected DSM market potential study, would be prudent and provides

good cause for a short extension of time. KCP&L and GMO also stated that the Staff of the Missouri Public Service Commission (Staff) and the Office of the Public Counsel (Public Counsel) had indicated no objection to the request.

The Commission directed that any responses to the request be made no later than March 10, 2017. Staff and Public Counsel each responded that they had no objection to the extension of time. Thus, the Commission finds that extending the filing and stakeholder meeting dates is reasonable and waiting for the DSM market potential study is good cause for extension.

#### THE COMMISSION ORDERS THAT:

- 1. Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's requests for an extension of time in which to file their 2017 Integrated Resource Plan Annual Updates and hold stakeholder meetings is granted.
- 2. Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file their 2017 Integrated Resource Plan Annual Updates no later than June 1, 2017 and hold stakeholder meetings within 30 days thereafter.
  - 3. This order shall be effective when issued.
  - This case shall close on March 14, 2017.
