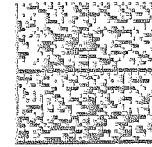

On August 21, 2019,<sup>1</sup> the Commission issued its Order Rejecting Fuel Adjustment Clause Tariff, Scheduling a Procedural Conference and Directing the Filing of a Revised Tariff. The Commission ordered KCP&L Greater Missouri Operations Company (the "Company") to file tariff sheet(s) to implement interim fuel adjustment rates to reflect any part of a proposed adjustment that is not in question. The August 21 order will be effective on August 31. On August 21, the Company filed Second Substitute Tariff Schedule to Adjust FAC Rate of KCP&L Greater Missouri Operations Company. The number for the proposed tariff is YE-2020-0033. The effective date is September 1, 2019. The Commission will order the Commission Staff to file a recommendation and allow any other party to do so.

**THE COMMISSION ORDERS THAT:**

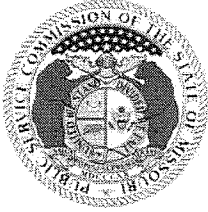
1. The Commission Staff shall file a recommendation no later than August 23, 2019.


