#### ORDER ESTABLISHING TEST YEAR

Evergy Missouri West, Inc. d/b/a Evergy Missouri West submitted tariff sheets on January 7, 2022, to produce a net increase in its electric base rates. The Commission set a time for responses to the test year and true-up period proposed by Evergy Missouri West. No party has objected or otherwise responded to the proposed test year of the twelve month period ending June 30, 2021, updated through December 31, 2021, or to the proposed true-up date of May 31, 2022. The Commission finds the proposed test year to be reasonable and will establish it as the test year, with the requested true-up period.

#### THE COMMISSION ORDERS THAT:

- 1. The test year for Evergy Missouri West's request to implement a general rate increase for its electric service shall be the twelve month period ending June 30, 2021, updated through December 31, 2021, to be trued-up through May 31, 2022.
  - 2. This order shall be effective upon issuance.
