NOTICE ACKNOWLEDGING WITHDRAWAL OF INCORRECTLY FILED TARIFF SHEETS

On December 21, 2022,¹ Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed substitute tariff sheets, which included a Letter of Transmittal, but without discussion of the changes. Pertinent here is a correction made in the December 21 filing that involves the Business Electric Vehicle (EV) Charging Service (BEVCS) and the Special High-Load Factor Market Rate (Schedule MKT).

On December 2, Evergy filed compliance tariff sheets. Those compliance tariff sheets were assigned Tracking No. YE-2023-0105. In that December 2 filing, Evergy inadvertently filed the BEVCS program as Original Sheet Nos. 158 and 158.1. Also, Schedule MKT was incorrectly listed in the Table of Contents to be at Sheet No. 165 in this filing.

On December 21, Evergy filed a substitute for Tracking No. YE-2023-0105, which correctly labeled the BEVCS tariff as Original Sheet Nos. 167 and 167.1. The December 21 substitute filing also corrects Schedule MKT in the Table of Contents.

The Commission recognizes Evergy's December 21 filing was meant to withdraw its changes to Sheet Nos. 158 and 158.1. The BECVS tariff as approved by the
