ORDER MODIFYING THE PROCEDURAL SCHEDULE

On March 29, 2023, Union Electric Company d/b/a Ameren Missouri filed a request on behalf of the Staff of the Missouri Public Service Commission; the Office of the Public Counsel; Missouri Industrial Energy Consumers; Midwest Energy Consumers Group; Consumers Council of Missouri; and the Sierra Club, to modify the procedural schedule. Ameren Missouri's motion informed the Commission that the parties to this rate case have reached an agreement that would resolve all the issues pertaining to the revenue requirement, leaving four issues for the Commission's determination. The parties are working to finalize a stipulation codifying their agreement.

Ameren Missouri asks the Commission to cancel the first week of the evidentiary hearing in this case, which is set to commence on April 3, 2023, and part of the second week. The evidentiary hearing on the remaining issues would begin on April 12, 2023. The Commission will modify the procedural schedule accordingly.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is modified so that the evidentiary hearing set to begin on April 3, 2023, will instead begin on April 12, 2023, at 8:30 a.m. in room 310 of the Governor Office Building.
