Pursuant to the Commission's *Order Rejecting Tariff to Change Fuel Adjustment Rates* issued on August 24, 2022, Evergy Missouri West, after consultation with the Staff of the Commission and the Office of Public Counsel, filed a *Proposed Procedural Schedule* on September 12, 2022. The Commission will adopt the procedural schedule proposed by the parties, but with changes to the briefing dates and the addition of a deadline for filing the transcript.

Reply Briefs	-	October 21, 2022

2. Responses to data requests shall be made within five business days and objections to data requests shall be made within two business days.

3. The hearing shall be held at the Commission's office at the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act.
