**JOINT MOTION TO ESTABLISH
ADDITIONAL PROCEDURAL DATES**

SBC Missouri¹ and the Joint Sponsors² respectfully propose the following procedural schedule for the presentation of revised rates that conform to the Missouri Public Service Commission's August 6, 2002 Report and Order in this case:

SBC Missouri Submission of Revised Rates	April 25, 2003
Other Parties' Objections or Comments on Revised Rates	May 16, 2003
SBC Missouri Reply and Objections or Comments	May 30, 2003

Counsel for Staff and Office of the Public Counsel have authorized the parties to this Motion to represent that Staff and Public Counsel concur in this recommendation.

WHEREFORE, SBC Missouri and Joint Sponsors respectfully request the Commission to adopt the additional procedural dates outlined above for the presentation of revised rates to the Commission.
