ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: March 17, 2008 Effective Date: March 23, 2008

On February 14, 2008,¹ the Commission issued its final Report and Order ("Order") in this matter bearing an effective date of February 24. In the Order, the Commission directed Missouri Gas Energy ("MGE") to file an updated tariff sheet reflecting its correct certificated service areas for Platte County, Missouri. On February 22, MGE filed its revised tariff sheet P.S.C. MO. No. 1, Sheet No. 6.15, assigned Tariff No. YG-2008-0509 and bearing an effective date of March 23.

On February 25, the Commission directed its Staff to file a recommendation advising the Commission whether the revised tariff sheet was in compliance with the Order. On March 7, MGE filed a substitute tariff sheet for its revised tariff sheet P.S.C. MO. No. 1, Sheet No. 6.15 making a specific reference to ordered paragraph number 7 in the Order, and on March 11, MGE filed another substitute tariff sheet correcting an omission of the company name. The effective date for the tariff sheet of March 23 remained unchanged.

On March 14, Staff filed its recommendation and verified memorandum. Staff finds the March 11 substitute tariff sheet accurately reflects MGE's certificated service areas for Platte County, Missouri. Staff finds the tariff sheet to be in compliance with paragraphs 2, 3, 4 and 7 of the Order and recommends that the Commission approve the submitted tariff, or to allow it to go into effect by operation by law on its effective date of March 23, 2008.

Staff also notes that as part of its discussions with MGE concerning tariff sheet 6.15, MGE provided Staff with a Leavenworth Supply Line ("LSL") Service Map precisely locating the LSL and Seven Bridges subdivision in relation to MGE's service area sections. Staff recommends that this map be accepted as part of MGE's compliance with paragraph 8 of the Order. (On February 26, the Commission set the deadline for compliance with paragraph 8 for May 26). Staff further recommends that when MGE complies with paragraph 8 of the Order, MGE should also be required to update its tariff sheets Nos. 7 and 8 of P.S.C. MO. No. 1. Staff states that these two sheets are comprised of maps of MGE's certificated areas and that these sheets should now be brought into conformity with MGE's updated tariffs.

IT IS ORDERED THAT:

1. The substitute tariff sheet filed by Missouri Gas Energy on March 11, 2008, pursuant to the Commission's February 14, 2008 Report and Order, assigned Tariff No. YG-2008-0509, is approved to become effective on March 23, 2008. The tariff sheet approved is:

P.S.C. MO. No.1 First Revised Sheet No. 6.15, Canceling Original Sheet No. 6.15

2. The Leavenworth Supply Line Service Map submitted to the Staff of the Missouri Public Service Commission by MGE is accepted as part of Missouri Gas

Energy's compliance with paragraph 8 of the Commission's February 14, 2008 Report

and Order in this matter.

3. No later than May 26, 2008, as part of its compliance with paragraph 8 of

the Commission's February 14, 2008 Report and Order in this matter, Missouri Gas

Energy shall update tariff sheets 7 and 8 of its P.S.C. MO. No. 1 tariff to accurately

reflect their maps of their certificated service areas.

3. This order shall become effective on March 23, 2008.
