STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Recommendation, states as follows:

1. On October 13, 2009, Southern Missouri Natural Gas Company, L.P. (SMNG or Company) filed the above-captioned application seeking a certificate of convenience and necessity (CCN) authorizing it to serve Willard Asphalt Paving, Inc. in an area of Laclede County where it does not currently hold a certificate for natural gas service.

2. On November 2, 2009, after no applications to intervene were filed, the Commission ordered Staff to file a recommendation no later than November 25, 2009.

3. On November 20, 2009, the Company filed its First Amended Application correcting and supplementing its original Application. The Commission thereafter ordered Staff to file its recommendation by December 10, 2009. Staff further notes that any motions to intervene from persons listed in the First Amended Application are due December 8, 2009.

4. Section 393.170 RSMo requires the Commission to address the question of approving the service territory of public utilities and whether the provision of that service is

necessary or convenient. Commission Rule 4 CSR 240-3.205(1)(E) requires applicants to state "The facts showing that the granting of the application is required by the public convenience and necessity." The term "necessity" means the additional service would be an improvement justifying its costs.¹ Furthermore, the Commission's allocation of service territory must be done on the basis of public interest.²

5. Members of the Staff's Tariff/Rate Design, Auditing, and Procurement Analysis Departments have reviewed SMNG's application. The Staff submits its verified Recommendation in Staff's Memorandum attached hereto as Appendix A. For reasons more fully explained in Staff's Memorandum, the Staff recommends the Commission approve SMNG's application. Based on Staff's review of SMNG's application, Staff believes approval is required by public convenience and necessity and is in the public interest. Therefore, Staff recommends the Commission grant SMNG a certificate of convenience and necessity to serve the additional areas of Laclede County necessary to serve the asphalt plant, with the understanding that the failure of the proposed extension will not affect the Company's rates.

WHEREFORE, for the above stated reasons, Staff respectfully recommends the Commission grant Southern Missouri Natural Gas Company, L.P. a certificate of convenience and necessity for the service areas described in the application.

On October 13, 2009, Southern Missouri Natural Gas Company, L.P. ("SMNG" or "Company") d/b/a Southern Missouri Natural Gas Company of Mountain Grove, Missouri, filed an Application and Motion for Expedited Treatment ("Application") requesting a certificate of convenience and necessity to serve Willard Asphalt Paving, Inc. in an area of Laclede county where it does not currently hold a certificate for natural gas service.

The Company submitted a feasibility study showing the extension to serve the asphalt plant will be profitable within ten years, and that the plant will be served at current rates.

Staff from the Procurement Analysis Department reviewed the proposed expansion for any impacts, positive or negative, on other customers including reliability for transportation capacity for peak day planning. SMNG explained because Willard Asphalt Paving operates only in the summer, it will not impact SMNG's available winter month capacity. However, the asphalt plant has diesel back-up in case of reliability issues. SMNG further explained any capacity release to the asphalt plant would reduce costs to SMNG's other customers.

On November 20, 2009, SMNG amended its application to include reference to its limited partnership agreement, fictitious name registration, and plans for financing as required under 4 CSR 204-2.060(1) and (E) and 4 CSR 240-3.205(1)(A)5(3), respectively. The Company also submitted the corrected addresses of two landowners to comply with 4 CSR 240-3.205(1)(A)2.

The Energy Department – Tariffs/Rate Design Staff (Staff) has verified that the Company has filed its annual report and is not delinquent on any assessment. Staff has reviewed this filing and is not aware of any issue currently pending before the Commission that affects or is affected by this filing.

Therefore, Staff recommends the Commission approve SMNG's application and allow it to serve the additional areas of Laclede county necessary to serve the asphalt plant, with the understanding that the failure of the proposed extension will not affect the Company's rates.
