1. On June 7, 2013, Staff filed its *Recommendation to Grant Certificate of Convenience and Necessity* ("*Recommendation*") concerning the *Application* filed by Missouri Gas Energy (MGE), a division of Southern Union Company.

2. In Staff's Memorandum, attached as Appendix A to its *Recommendation*, Staff stated that MGE's estimated cost of the project is \$24,891.10. This is an error. MGE's estimated cost of the project is \$59,217.
