FOXFIRE UTILITY COMPANY'S NOTICE OF INTENDED CASE FILING

COMES NOW Foxfire Utility Company ("Foxfire"), pursuant to Commission Rule 20 CSR 4240-4.017, and, as its *Notice of Intended Case Filing*, respectfully states as follows to the Missouri Public Service Commission ("Commission"):

1. Foxfire is a Missouri corporation with its principal office and place of business at

3478 Smyrna Road, Rogersville, Missouri 65742. Foxfire currently provides water and sewer

service to approximately 258 billed locations in an unincorporated area in Stone County,

Missouri, pursuant to certificates granted by the Commission. Foxfire is a "water corporation,"

a "sewer corporation" and a "public utility" as those terms are defined in Section 386.020 RSMo,

and is subject to the jurisdiction and supervision of the Commission as provided by law.

2. Commission Rule 4 CSR 240-4.017(1) provides, in part, as follows:

Any person that intends to file a case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case. Such notice shall detail the type of case and issues likely to be before the commission and shall include a summary of all communication regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to filing the notice.

3. It is Foxfire's intent to file an application to sell its remaining water and sewer assets to Ozark Clean Water Company ("OCWC"), a Missouri 501(c)(3) not-for-profit corporation, within the next 60-180 days. Issues likely to be before the Commission in the upcoming application

case include those concerning the jurisdiction of the Commission after consummation of the proposed sale, and the public interest regarding the proposed sale of water and sewer assets of Foxfire to OCWC.

4. No communications regarding substantive issues likely to be in this case have taken place between Foxfire and the office of the Commission in the ninety (90) days prior to this filing.

WHEREFORE, Foxfire Utility Company submits to the Commission and its Secretary this Notice of Intended Case Filing.
