APPLICATION TO INTERVENE

The Missouri Propane Gas Association, pursuant to 4 CSR 240-2.075, requests that it be granted intervention in this matter. In support thereof, the Missouri Propane Gas Association states as follows:

1. The Missouri Propane Gas Association ("MPGA") is a Missouri not-for-profit Corporation. A Certificate of Good Standing is attached as Exhibit A.
2. The MPGA's place of business is 4110 Country Club Drive, Jefferson City, Missouri, 65109.
3. The MPGA represents the interests of propane gas retailers throughout the State of Missouri.
4. A list of the MPGA's members is attached hereto as Exhibit B in compliance with 4 CSR 240-2.060(1)(J) and 4 CSR 240-2.075(3) and incorporated by reference herein.
5. The MPGA has several members in the area of proposed service that will be directly and economically impacted by any Order of this Commission concerning the application at issue in this case.
6. The MPGA seeks intervention for the purpose of protecting the interests of its members, the interests of propane gas consumers in the proposed area of service and for the

purpose of providing this Commission with valuable and necessary information concerning both the service area, propane and natural gas generally.

7. Although the MPGA has only limited information concerning the application at issue, based upon publicly available information and feedback from its members, MPGA anticipates it will oppose the application.

8. The MPGA and its component members have an interest that is different than that of the general public in that the MPGA's members are competitors with the applicant and the MPGA's members currently serve some of the same customers who will be affected and impacted if the application shall be granted.

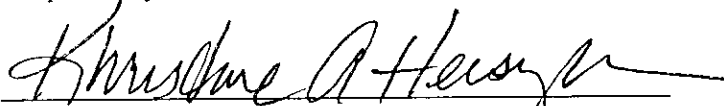
9. For example, if the application is granted and customers choose to convert from propane to natural gas, MPGA members in the service area will suffer economic impact as a result of not just losing customers, but being required to convert equipment in the service area as customers switch back and forth between natural gas and propane.

10. As such, the MPGA and its members may be adversely affected by a Final Order arising from this case, both from an economic and practical standpoint.

11. Granting the proposed intervention would serve the public interest because it would provide additional input to the Commission and analysis of the applicant's proposal as well as additional information concerning the market for natural gas and propane, as well as the possible effect on customers who currently are not being provided with natural gas.

WHEREFORE, the Missouri Propane Gas Association respectfully requests that it be granted intervention in the above-captioned matter.

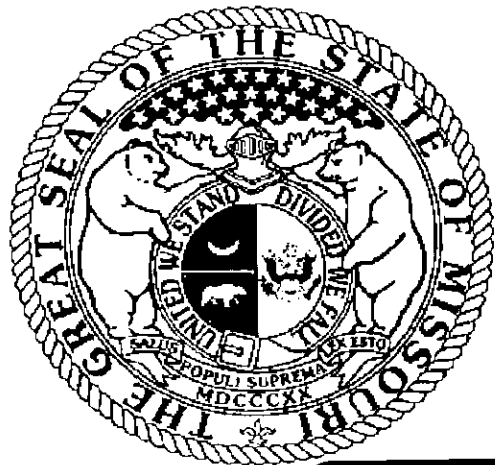

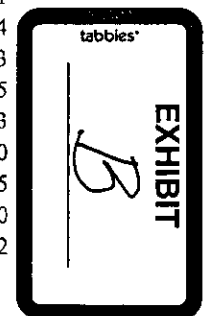
