(MGU or Company), filed tariff sheets with the Missouri Public Service Commission (Commission) to comply with the Commission's ORDER GRANTING CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY (Order), issued June 19, 2008, in this case. On July 11, 2008, MGU filed substitute tariff sheets The substitute sheets make modifications to MGU's tariff to the description of MGU's service area in the heading (the counties are listed instead of certain municipalities), and the map on Sheet No. 3 also contains a change to better identify the location of Pattonsburg.
