The Commission previously issued an order granting the application of Summit Natural Gas of Missouri, Inc. ("Summit") for authority to expand its certificated service territory. On May 12, 2017, Summit filed tariff sheets (Tracking No. YG-2017-0237) revising the map and legal description of its certificated area. The revised tariff sheets have a June 11, 2017 effective date. The Commission will set a deadline for parties to file recommendations or objections to the tariff sheets.

1. No later than May 30, 2017, parties may file recommendations or objections to Summit's tariff sheets, assigned Tracking No. YG-2017-0237.
2. This order shall be effective when issued.
