MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY AND ACCOMPANYING TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff), through the undersigned counsel, and moves for the Missouri Public Service Commission (Commission) to cancel FreedomStarr Communications Inc.'s (FreedomStarr or Company) certificate of service authority to provide competitive interexchange telecommunications services and the associated tariff. For this Motion, Staff respectfully states the following:

- On January 21, 1999, the Commission issued an Order, granting a certificate of service authority to FreedomStarr to provide competitive interexchange telecommunications services. The Order also approved FreedomStarr's tariff, JX-2003-0560, Mo. P.S.C.
 Tariff No. 1.
- 2. FreedomStarr was a registered California corporation located at 7895 Santa Monica Blvd. Suite 109 PMB 7, West Hollywood, CA 90046, which was registered with the Missouri Secretary of State. According to the Missouri Secretary of State Office, FreedomStarr was administratively dissolved on November 7, 2006, for failure to maintain a registered agent. According to section 351.486.3 RSMo, 2000,
 - "A corporation administratively dissolved continues its corporate existence but may not carry on any business except that which is necessary to wind up and liquidate its business and affairs . . . and any officer or director who conducts business on behalf of a corporation so dissolved except as provided in this section shall be personally liable for any obligation so incurred."

In 2007, FreedomStarr filed an annual report with the Missouri Public Service Commission, and FreedomStarr reported that it had \$4,138.00 Missouri Jurisdictional Revenue in 2006. In 2008, the final year FreedomStarr filed an annual report with the Missouri Public Service Commission, FreedomStarr reported that it had \$3,787.00 Missouri Jurisdictional Revenue in 2007. These annual reports show that FreedomStarr continued to do business in Missouri after it was no longer registered with the Missouri Secretary of State Office.

- FreedomStarr has not filed an annual report with the Missouri Public Service Commission for the year 2008 as mandated by section 392.210.1 RSMo, 2000, and 4 CSR 240-3.165.9.
- 4. FreedomStarr has no outstanding Assessment Payment.
- 5. The Commission has the authority to cancel the certificate of service authority of a telecommunications corporation pursuant to section 392.410.5 RSMo, 2000, which states "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 6. According to Section 506.150 RSMo, 2000, service is proper on a dissolved corporation either at the Missouri Secretary of State's Office or the last registered agent. The Secretary of State is located at James C. Kirkpatrick State Information Center, PO Box 778 Jefferson City, Missouri 65102. The last known registered agent of FreedomStarr was C T Corporation System, 120 South Central Ave., Clayton, MO 63105.

WHEREFORE, Staff avers a good faith belief that FreedomStarr Communications, Inc. is no longer doing business in the State of Missouri, further staff recommends the Commission

cancel the certificate of service authority granted to FreedomStarr Communications, Inc. to provide intrastate interexchange telecommunications services and the accompanying tariff Public Service Commission Tariff No. 1.
