ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDERS

Issue Date: July 28, 2008

Effective Date: August 6, 2008

On April 4, 2008,¹ Missouri Gas Utility, Inc., ("MGU") applied for a certificate of public convenience and necessity to construct, install, own, operate, control, manage and maintain a natural gas distribution system in a portion of Harrison County, Missouri (Case No. GA-2008-0321). MGU asked to serve Ridgeway, Missouri, for which MGU has a franchise agreement. The legal description of the area MGU wishes to serve as listed in the instant application is Sections 31, 32, 33, and 34, in Township 65 North,

Range 27 West, and Sections 3, 4, 5, and 6 in Township 65 North, Range 27 West, all in Harrison County.

On April 7, 2008, MGU applied for a certificate of public convenience and necessity to construct, install, own, operate, control, manage and maintain a natural gas distribution system in a portion of Daviess County, Missouri (Case No. GA-2008-0322). MGU asked to serve Pattonsburg, Missouri, for which MGU has a franchise agreement. The legal description of the area MGU wishes to serve as listed in the instant application is Sections 5, 6, 7, 8, 18 and 19, in Township 61 North, Range 28 West, and Sections 1, 12, 13, and 24 in Township 61 North, Range 29 West, all in Daviess County.

On April 22, 2008, MGU applied for a certificate of public convenience and necessity to construct, install, own, operate, control, manage and maintain a natural gas distribution system in a portion of Daviess County, Missouri (Case No. GA-2008-0348). MGU asked to serve Jamesport, Missouri, for which MGU has a franchise agreement. The legal description of the area MGU wishes to serve as listed in the instant application is Sections 2, 3, 4, 5, 6, and 8 in Township 59 North, Range 26 West, and Sections 26, 27, 28, 32, 33, 34 and 35 in Township 60 North, Range 26 West, all in Daviess County.

On June 19, The Commission granted the requested certificates and instructed MGU to file tariffs to reflect the changes to their service areas. On July 7, MGU filed tariff sheets in its attempt to be in compliance with the Commission's orders. MGU filed only one set of tariff sheets to encompass the changes from all three cases (GA-2008-0321, GA-2008-0322 and GA-2008-0348), which was assigned tariff tracking number YG-2009-0025, and the Commission directed its Staff to review those tariff sheets and

provide a recommendation as to if they were in compliance with the orders granting the certificates. On July 11, MGU filed substitute tariff sheets making modifications to clarify the description of MGU's service area.

On July 25, Staff filed its recommendations in each of these matters. Staff finds that the tariff sheets are in compliance with the Commission orders granting the CCNs. Staff has also verified that MGU has filed its annual report and is not delinquent on any assessment. Staff recommends the Commission approve the tariff sheets to become effective on August 6, 2008.

The Commission has reviewed MGU's tariff filings and Staff's verified recommendation and memorandum and finds that MGU's tariff sheets should be approved to become effective on August 6, 2008.

IT IS ORDERED THAT:

1. The tariff sheets filed by Missouri Gas Utility, Inc., on July 7, 2008, pursuant to the Commission's June 19, 2008 Orders granting Certificates of Convenience and necessity, and substituted on July 11, 2008, assigned Tariff Tracking No. YG-2009-0025, are approved to become effective on August 6, 2008. The tariff sheets approved are:
