**ORDER DIRECTING NOTICE, SETTING DATE FOR SUBMISSION
OF INTERVENTION REQUESTS, AND DIRECTING FILING**

On May 22, 2009, Missouri Gas Utility, Inc. (MGU), filed an application with the Missouri Public Service Commission requesting that the Commission grant MGU authority to provide natural gas service to customers in Benton County, Missouri. This application is in conjunction with the previously granted authority from Case No. GA-2009-0264. MGU is requesting additional authority because of a change in the route of the main line for service to Cole Camp. Thus, MGU requests that the Commission grant it additional service territory in Benton County. In addition, MGU requests that the authority be granted no later than August 1, 2009.

The Commission finds that notice of MGU's application should be given to the general public and potential interested parties and that a date for intervention of proper parties should be set. The Commission's Data Center shall mail a copy of this notice to the county commission of Benton County. The Data Center shall also send a copy of this notice to the landowners listed in Appendix B of the application. In addition, the Commission's public information officer shall make notice of this order available to the media

serving Benton County and to the members of the General Assembly representing Benton County.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is granted intervention and neither the Staff of the Commission nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and decide the case on the basis of the verified application and Staff recommendation.

In addition, because the company has asked for expedited treatment, the Commission directs its Staff to respond to that motion and will set a time for any other response to the motion for expedited treatment and the application.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall mail a copy of this notice to the county commission of Benton County and the landowners listed in Appendix B of the application.
2. The Missouri Public Service Commission's public information officer shall make notice of this order available to the media serving Benton County and to the members of the General Assembly representing Benton County.
3. Any person wishing to intervene in this matter shall file an application to do so no later than June 16, 2009. Such applications shall be filed with:

4. Any response to the motion for expedited treatment shall be filed no later than June 8, 2009.

5. The Staff of the Missouri Public Service Commission shall file a recommendation regarding the application or a status report indicating the earliest date on which it expects to file a status report no later than June 16, 2009.

6. Any response to the report or recommendation filed by the Staff of the Missouri Public Service Commission shall be filed no later than ten days following the filing of that report or recommendation unless otherwise ordered.

7. This order is effective upon issuance.

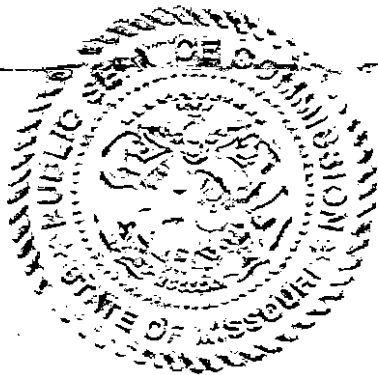
