The Commission is giving notice of the application to persons listed in the Supplement to Application ("supplement") that Missouri Gas Utility, Inc., ("MGU") and setting a deadline for motions to intervene.

MGU filed the application described in the title of this action ("application") on July 9, 2009. The application seeks the Commission's permission and approval to construct gas facilities and provide gas service. Legal descriptions ("proposed service area") locating such proposed construction and service appear in the application's paragraph 8 and appendix A, and the names of ten persons residing or owning land in the proposed service area appears in paragraph 13.

As to two such persons, MGU filed the supplement on July 21, 2009, setting forth better addresses. The Commission has already directed its staff to file a recommendation on the application. The statutory requirement of a "due hearing"<sup>1</sup>
