## NOTICE OF APPLICATION AND ORDER DIRECTING FILING

On November 7, 2016, the City of Harrisonville, Missouri ("City") and KCP&L Greater Missouri Operations Company ("GMO"), (collectively, "Joint Applicants") filed an application asking the Commission to approve a territorial agreement pursuant to Sections 416.041 and 394.312, RSMo.

The Commission will provide notice of the filing of this territorial agreement to the public. In addition, the Commission will establish a deadline for the filing of applications to intervene and will order its Staff to file a recommendation regarding the joint application. If no party files a motion for an evidentiary hearing, the Commission may deem the right to an evidentiary hearing waived. The controlling statute requires the Commission to rule on the application no later than 120 days from the date the application was filed.

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to the County Commission of Cass County, Missouri.

2. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing Cass County, Missouri and to the newspapers serving that county.

3. Applications to intervene shall be filed no later than November 22, 2016.

4. The Commission's Staff shall file a recommendation regarding the joint application no later than December 6, 2016.

5. This order shall be effective when issued.
