On April 13, 2017, KCP&L Greater Missouri Operations Company (GMO) filed its 2017 Renewable Energy Standard Compliance Plan, as required by Commission Rule 4 CSR 240-20.100(8). Renew Missouri Advocates applied to intervene on April 18.
