**ORDER GRANTING APPLICATIONS TO INTERVENE**

On October 31, 2017, The Empire District Electric Company applied to the Commission for approval of its proposed plan to achieve customer savings through the development of wind generation using federal tax incentives in conjunction with a tax equity partner and the retirement of a coal-fired unit. On November 1, 2017, the Commission issued an order directing notice of the application and setting a deadline of November 22, 2017 for persons requesting to intervene in this matter.

The Midwest Energy Consumers Group, Renew Missouri Advocates, the Missouri Department of Economic Development – Division of Energy, the City of Joplin, Missouri, Sierra Club, and Union Electric Company d/b/a Ameren Missouri filed timely applications to intervene. No party objected to the applications by the deadline set by the Commission. The applications satisfy all requirements of Commission Rule 4 CSR 240-2.075 and intervention will be granted.

**THE COMMISSION ORDERS THAT:**

1. The application to intervene filed by the Midwest Energy Consumers Group is granted.
2. The application to intervene filed by Renew Missouri Advocates is granted.

3. The application to intervene filed by the Missouri Department of Economic Development – Division of Energy is granted.

4. The application to intervene filed by the City of Joplin, Missouri is granted.

5. The application to intervene filed by Sierra Club is granted.

6. The application to intervene filed by Union Electric Company d/b/a Ameren Missouri is granted.

7. This order shall be effective when issued.
