## ORDER SETTING PREHEARING CONFERENCE

On November 2, 2017, Matt Mylott filed an application to change his electrical service provider from The Empire District Electric Company to White River Valley Electric Cooperative, Inc. After notice was issued, both companies filed responses to the application. The Staff of the Missouri Public Service Commission ("Staff") was directed to investigate and respond. On January 19, 2018, Staff filed a recommendation that the Commission approve the application. Empire opposes the application. In order to discuss a procedural schedule and possible settlement of this matter, the Commission will set a prehearing conference. In addition, for the convenience of the parties, they may appear by telephone as set out below.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on February 14, 2018 at 10:00 a.m.
2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall

Any party may participate in the prehearing conference by telephone by dialing (573) 526-5402 or (866) 630-9346 at the start time of the conference.

3. This order shall be effective when issued.
