ORDER APPROVING TARIFF TO CHANGE FUEL ADJUSTMENT CLAUSE RATES

Issue Date: November 12, 2014 Effective Date: December 1, 2014

On October 1, 2014, The Empire District Electric Company ("Empire") submitted a tariff sheet to implement an adjustment to its Fuel Adjustment Rates ("FAR") pursuant to its Fuel Adjustment Clause ("FAC"). The requested adjustments would decrease the FAC of an Empire residential customer's monthly bill from \$1.73 to \$1.08; a decrease of \$0.65 per month. The effective date of the tariff sheet (Tracking No. JE-2015-0137) is December 1, 2014.

The Commission's Staff filed a recommendation regarding Empire's tariff on October 27, 2014. Staff verified that Empire's actual fuel and purchased power costs, plus net emissions allowance costs, less off-system sales revenue and renewable energy credits, match Empire's calculated rates submitted in the tariff. Staff also reviewed Empire's monthly interest rates that are applied to the monthly over/under recovery amounts for Accumulation Period 12, a portion of Recovery Period 11, and a portion of Recovery Period 10. Staff recommended the Commission issue an order approving the proposed tariff sheet, subject to

both true-up and prudence reviews. More than ten days have passed since Staff filed its recommendation and no party has filed a response to that recommendation.¹

Based on the Direct Testimony of Todd Tarter, submitted by Empire along with its tariff sheet, and the recommendation of Staff, the Commission will approve Empire's proposed rate schedule.

THE COMMISSION ORDERS THAT:

1. The rate schedule submitted by The Empire District Electric Company as Tariff No. JE-2015-0137, is approved as an interim rate adjustment, subject to true-up and prudence reviews, to become effective on December 1, 2014. The tariff sheet approved is:
