## **APPLICATION TO INTERVENE**

The Empire District Electric Company (Empire), pursuant to Missouri Public Service Commission (Commission) Rule 4 CSR 240-2.075 and the Commission's Order and Notice, requests that it be allowed to intervene in the above-entitled matter. In support of its application, Empire states as follows:

- 1. Empire is a Kansas corporation with its principal office and place of business at 602 Joplin Street (P.O. Box 127), Joplin, Missouri 64801 (64802). Empire is engaged in the business of providing electric and water utility services to customers in its service areas in Missouri. Empire also holds a certificate of service authority to provide certain telecommunications services.
- 2. Empire is an "electrical corporation," a "water corporation," a "telecommunications company," and a "public utility" as those terms are defined in Section 386.020 RSMo 2000, and is subject to the jurisdiction and supervision of the Commission, as provided by law.
- 3. Empire has no final, unsatisfied judgments or decisions against it from state or federal regulatory agencies or courts that involve customer service and that have occurred within the three (3) years immediately preceding the filing of this application, and has no overdue Commission annual reports or assessment fees.

Empire has a general rate case pending before the Commission, Case No. ER-2006-0315.

- 4. Empire's documents of incorporation were filed with the Commission in Case No. EF-94-39 and said documents are incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G). A Certificate of Authority from the Missouri Secretary of State to the effect that Empire, a foreign corporation, is authorized to do business in the State of Missouri, was filed with the Commission in Case No. EM-2000-369 and is also incorporated by reference.
- 5. Pleadings, notices, orders, and other correspondence and communications concerning this application should be addressed to the undersigned counsel and also to:
