

TO: The Public Service Commission of the State of Missouri

My husband and myself are concerned that the transfer and assignment of the utility assets on Big Island to the homeowners of the Big Island Water Company and the Big Island Sewer Company, will affect the tax revenues associated with my property on Big Island, in Camden county. There has been no disclosure regarding this fact.

There has been very little public disclosure regarding the impact and affect the transfer of the utility assets to homeowners will have.

I want to make my concern and objection known to the Missouri Public Service Commission, regarding the requirement of the Big Island Water Company to cap my private well, should I decide to connect and take service from this system. I am an individual property owner, who shares a private with another individual property owner. The requirement to cap my private well by the Big Island Water Company, would create a legal situation between myself and the individual property owner sharing the well. The pretense under which the requirement to cap my private well is made, is questionable; as I have the same concern that water or sewage from the water or sewer company could also affect my private well.

It is my understanding that complaints regarding this utility have been before the Public Service Commission for nearly 2 years. However, the formation of the Big Island Water and Sewer Companies, and the vote to transfer the utility assets to the homeowners, and the actions to do so, have been expedited, and resulted in very little public information being disclosed, and thus many questions being raised.

Any and all documents involved in, or associated with this transfer, should be made available to every homeowner to allow them to inform themselves, and seek legal advice before deciding a vote on this issue.
