On behalf of The Empire District Electric Company (Empire), I am providing herewith to the Missouri Public Service Commission (Commission) for filing in electronic form certain tariff sheets consisting of revised electric rate schedules which are designed to increase Empire's gross annual electric revenues by approximately \$29,513,713, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes.
