Dear Ms. Dale:

In accordance with 4 CSR 240-20.090(4), on behalf of The Empire District Electric Company ("Empire" or "Company"), I am herewith submitting to the Missouri Public Service Commission ("Commission"), for filing in electronic form, proposed rate schedules to adjust charges related to the Company's approved Fuel Adjustment Clause ("FAC"). The proposed rate schedules bear an issue date of October 1, 2009, and an effective date of December 1, 2009.

During the most recent Accumulation Period (March 1 to August 31) in Empire's FAC, Empire's overall fuel and purchased power costs have decreased by approximately \$0.876 million; in accordance with the terms of Empire's approved FAC, the proposed rate schedules are designed to refund to the Missouri customers only 95 percent of the Missouri related cost decrease, or approximately \$0.820 million, including interest.

As explained in the direct testimony and supporting schedules of W. Scott Keith, Empire's Director of Planning and Regulatory, which is being filed in support of the proposed rate schedules, the major factors that have caused the proposed decreases in FAC-related charges include cooler than normal weather conditions, lower natural gas usage, lower natural gas prices and lower spot purchased power prices.

Also provided in electronic form are schedules containing all of the information required by 4 CSR 240-3.161(7) and all workpapers that support the proposed rate schedules.

Copies of Empire's proposed FAC-related rate schedules and all supporting materials described in this letter will be served electronically, this date, on the Commission's General Counsel, the Office of the Public Counsel, and on each party to the Company's last general rate case.
