## ORDER SETTING PROCEDURAL CONFERENCE

On April 30, 2018, the Staff of the Missouri Public Service Commission (Staff) submitted its first Missouri Energy Efficiency Investment Act (MEEIA) Cycle 2 prudence review report for Union Electric Company d/b/a Ameren Missouri. The report contains proposed adjustments with a total disallowance of \$79,313. On May 3, 2018, Ameren Missouri requested a hearing. In addition, Ameren Missouri requested that the Commission set a date for a procedural conference for the purpose of discussing settlement and, if necessary, a procedural schedule. The Commission will grant the request for a procedural conference as set out below.

#### THE COMMISSION ORDERS THAT:

- 1. The parties shall appear at a procedural conference to be held on June 12, 2018 at 9:00 a.m.
