4 CSR 240-121.050 Inspection of Preowned Manufactured Homes Rented, Leased or Sold or Offered for Rent, Lease or Sale by Persons Other Than Dealers.

PURPOSE: This rule is being rescinded in its entirety because it is no longer necessary.
