On December 22, 2016, the Staff of the Missouri Public Service Commission filed its *Report of Second MEEIA Prudence Review and Proposed Adjustments*. Based on its audit of the costs associated with Union Electric Company d/b/a Ameren Missouri's Demand Side Investment Mechanism program, Staff recommends a disallowance through October 2016 of \$92,456. Ameren Missouri filed a timely request for hearing. The Commission will schedule a prehearing conference.

THE COMMISSION ORDERS THAT:

1. A prehearing conference will be held at 10:00 a.m. on Thursday, January 26, 2017, at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. 
