ORDER SETTING PROCEDURAL CONFERENCE

On February 6, 2017, Roger Pritchett filed an application with the Missouri Public Service Commission requesting that his electric supplier be changed from The Empire District Electric Company to Ozark Electric Cooperative, Inc. On May 9, 2017, the Commission's Staff filed a recommendation to deny Mr. Pritchett's request and to provide Mr. Pritchett an opportunity to submit additional information to establish that his request is in the public interest for a reason other than rate differential.

The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule and a date for an evidentiary hearing. The parties or their representatives shall appear in person or by telephone at the conference, unless excused by the regulatory law judge. Parties wishing to appear by telephone will be provided with a telephone conference number.

THE COMMISSION ORDERS THAT:

1. A procedural conference shall be held on Wednesday, June 7, 2017, beginning at 9:00 a.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional

3. This order shall be effective when issued.
