ORDER SETTING PROCEDURAL CONFERENCE

On April 20, 2017, Brandon Jessip filed an application with the Missouri Public Service Commission ("Commission") requesting that his electric supplier be changed from The Empire District Electric Company ("Empire") to New-Mac Electric Cooperative, Inc. ("New-Mac"). On May 24, 2017, Empire filed a response objecting to the application. On June 26, 2017, the Commission's Staff filed a motion to dismiss the application, which is opposed by both Empire and New-Mac.

The Commission finds that a procedural conference is now appropriate to discuss the motion to dismiss and filing deadlines for a procedural schedule, including a date for an evidentiary hearing. The parties or their representatives shall appear in person or by telephone at the conference, unless excused by the regulatory law judge. Parties wishing to appear by telephone will be provided with a telephone conference number.

THE COMMISSION ORDERS THAT:

1. A procedural conference shall be held on Wednesday, July 26, 2017, beginning at 2:00 p.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional

2. Any party that wants to participate in the conference by telephone may do so by calling **877-820-7831** and entering the access code **93348999#** at the time set for the beginning of the conference.

3. This order shall become effective when issued.
