**ORDER ADMITTING LATE-FILED AND LATE-OFFERED EXHIBITS**

The evidentiary hearing in this matter concluded on May 1, 2008.<sup>1</sup> On May 8, Counsel for the City of Independence late-filed, and offered into evidence, **Exhibit 1306**. Also on May 8, the City of Kansas City late-filed, and offered into evidence, **Exhibit 404**. On May 13, AG Processing Inc., Sedalia Industrial Energy Users' Association and Praxair, Inc. late-filed, and offered into evidence, **Exhibit 305**. On May 15, Kansas City Power and Light Company ("KCP&L") late-filed, and offered into evidence, **Exhibit 209**. On June 2, the Staff of the Missouri Public Service Commission late-filed, and offered into evidence, **Exhibit 147**.

The Commission established deadlines for responses to these filings, and no party objected to the admission of these exhibits. Consequently, the Commission shall admit these exhibits and receive them into the record. The Commission recognizes that the post-hearing briefing schedule has already passed in this matter.
