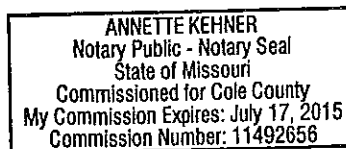

4 CSR 240-3.520 Filing Requirements for Telecommunications Company Applications for Authority to Sell, Assign, Lease or Transfer Assets. This rule set forth the requirements for applications to the commission for the authority to sell, assign, lease or transfer assets.

PURPOSE: This rule is rescinded in its entirety because the subject matter is no longer within the Missouri Public Service Commission's authority as described in Section 392.611.

PUBLIC COST: This proposed rescission will not cost state agencies or political subdivisions more than five-hundred dollars (\$500) in the aggregate.

PRIVATE COST: This proposed rescission will not cost private entities more than five-hundred dollars (\$500) in the aggregate.

AUTHORITY: section 386.250, RSMo 2000. Original rule filed Aug. 16, 2002, effective April 30, 2003. Amended: Filed March 19, 2004, effective Nov. 30, 2004.*
