On June 11, 2021, Union Electric Company d/b/a Ameren Missouri filed an application to lease fiber capacity to MCC Network Services, LLC. The Commission ordered the Staff of the Commission to file a recommendation no later than July 14, 2021.

On July 14, 2021, the Staff of the Commission filed a Motion for Extension. Staff states that it has data requests pending, and that it can file its recommendation by September 13, 2021. As such, Staff asks for an extension of time until September 13, 2021.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's motion for extension of time is granted.
2. The Staff of the Commission shall file a recommendation no later than September 13, 2021.
3. This order shall be effective when issued.
