Why would I do that? I am in business since 1986 selling insurance and MOST of my calls are people I do not know or they do not have caller ID. My cell phone does not have that either. That part about them trying to call me is a lie, plain and simple. They knew if they called first that I would say "NO"! Don't come! It is too late!. THAT is why they did not call!

In any case, the people in the truck called a lot of different people!
