PETITION

GENERAL ALLEGATIONS

COMES NOW Plaintiff Four Seasons Lakesites, Inc., by and through its attorneys, Curran & Sickal, and for its general allegations, states and alleges as follows:

1. Plaintiff, Four Seasons Lakesites (hereinafter "Lakesites"), Inc., is a corporation duly organized under the laws of the State of Missouri and authorized to do business therein.
2. Plaintiff in the past and at the present time engages in the development of real estate and the sale of parcels and lots of real property to third party purchasers in a development known generally as the "Four Seasons".
3. Defendant, Lake Region Water & Sewer Co., (hereinafter "Lake Region") is a corporation duly organized under the laws of the State of Missouri and authorized to do business therein and maintains a registered office in Camden County, Missouri.
4. Defendant Lake Region is engaged in the business of providing water and sewage utilities to residents of Camden County, Missouri, a portion of which reside within the Four Seasons development.
5. Defendant Waldo Morris (hereinafter "Morris"), the individual, regularly transacts business in the state of Missouri and is the sole shareholder of all Lake Region Water & Sewer Co. stock.
6. On or about July 7, 1998, Plaintiff's parent corporation Four Seasons Group, Inc. sold all of the outstanding stock in Four Seasons Water and Sewer Company to Roy and Cindy Slates (hereinafter "Slates"). The corporate name of Four Seasons Water and Sewer Company was subsequently changed to Lake Region Water and Sewer Company, one of the Defendants herein.
7. In connection with sale of the stock in Lake Region, Plaintiff Lakesites assigned to Slates certain "availability" or "standby" fees, which arose from contracts for the purchase of lots by third parties from Plaintiff; a copy of the Assignment is attached hereto and incorporated herein by reference as Exhibit "1". Further, Exhibit A of the Assignment contains an itemization of those standby fees assigned by Plaintiff to Slates.

8. At a date unknown to the Plaintiff, Slates pledged the stock in Lake Region and the assignment of the right to collect the specified "availability" or "standby" fees to Morris. Morris has advised Plaintiff that he has foreclosed on the pledge of the stock and assignment and now owns the stock of Lake Region and the Assignment.

COUNT I

COMES NOW Plaintiff, by and through its attorneys, and for its first cause of action against Defendants states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations as though fully set forth herein.
2. Since the date of Morris' acquisition of the stock of Lake Region, Defendants have billed for and collected "availability" and "standby" fees from third party lot purchasers who were not part of the availability fees transferred by the Assignment. i.e. not listed on Exhibit A to the Assignment.
3. Plaintiff lacks access to the information and data necessary to determine the precise amount wrongfully collected by Defendants.
4. By reason of Defendants' conduct, Plaintiff has been deprived of availability fees that belong to Plaintiff.
5. Plaintiff seeks an accounting to recover sums received by Defendants in the form of availability fees rightfully belonging to Plaintiff.
6. That Plaintiff has no adequate remedy at law.

WHEREFORE, Plaintiff prays for judgment against the Defendants as follows:

- A. That this Court enter an order for an immediate and complete accounting of all availability fees collected by Defendants from August 6, 1998 to present;
- B. For such other and further relief as this Court deems just and proper.

COUNT II

COMES NOW Plaintiff, by and through its attorneys, and for its second cause of action against Defendants, states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations and paragraphs 1 through 6 of Count I as though fully set forth herein.
2. Upon information and belief, since August 1998, the Defendants have wrongfully collected a sum of money in excess of \$322,000.00 in availability fees from third party purchasers of Four Season's lots purchased subsequent to August 6, 1998 that were not part of the Assignment. i.e. Defendants have collected availability fees from lot owners and lots not listed on Exhibit A of the Assignment.
3. As a result of Defendants' actions in misappropriating availability fees for their own use and profit, Plaintiff has suffered a loss of revenue and profit thereon and will continue to lose same in the future.
4. Plaintiff is entitled to interest upon the unpaid balance pursuant to RSMo §408.020 from the date of when Defendants collected such fees from each lot owner subsequent to August 6, 1998 to date of judgment.

WHEREFORE, Plaintiff prays that this court enter judgment against Defendants, jointly and severally, in the amount due and owing Plaintiff for availability fees determined by the Court as a result of the accounting requested in Count I, interest thereon to the date of judgment, court costs, and for such other and further relief as this court deems just and proper.

COUNT III

COMES NOW Plaintiff, Lakesites, by and through its attorneys and for its third cause of action against the separate Defendant, Lake Region, states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations and paragraphs 1 through 6 of Count I and paragraphs 1 through 4 of Count II as though fully set forth herein.
2. That subsequent in time to the sale of Stock Agreement Plaintiff and Defendant Lake Region entered into an oral agreement whereby Plaintiff was to have transferred to Defendant Lake Region all right, title and interest in a treatment plant and two lift stations as well as all fixtures and tangible personal property associated with said plant and lift stations, (hereinafter the "Assets") once the Missouri Public Service Commission (hereinafter "PSC") had added the area where such property was located to Lake Region's certificated area in exchange for Lake Region paying Plaintiff the sum of \$87,500.00.
3. Subsequent to such oral agreement, the PSC entered an order adding the area where the assets were located to Lake Region's certificated area.
4. Defendant Lake Region took control of such assets, has used, and continues to use, such assets in its business and for its own use and purpose, to the exclusion of Plaintiff.
5. That Defendant Lake Region has not paid Plaintiff for the assets.
6. Plaintiff has incurred a loss in the amount of \$87,500.00 as a result of Defendant's actions.

7. Pursuant to RSMo §408.020 Plaintiff is entitled to interest upon the unpaid balance from the date that Defendant Lake Region assumed control of the assets to date of judgment.
8. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation expenses in the prosecution of this action. Pursuant to RSMo §408.092, Plaintiff is entitled to recover such from the Defendant Lake Region.

WHEREFORE, Plaintiff prays that this court enter judgment against Defendant Lake Region in the principal amount of \$87,500.00, for interest pursuant to RSMo §408.020 from the date that Defendant Lake Region assumed control of the Assets to date of judgment and for attorneys' fees and related litigation expenses pursuant to §408.020 RSMo, for court costs, and for such other and further relief as this court deems just and proper.

COUNT IV

COMES NOW Plaintiff, by and through its attorneys, and in the alternative to Count III and for its fourth cause of action against Defendant Lake Region, states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II and paragraphs 1 through 8 of Count III, as though fully set forth herein.
2. At Defendant's request, Plaintiff relinquished control of a treatment plant, two lift stations and all attendant personalty to the Defendant Lake Region.
3. Defendant Lake Region now exercises complete control over such assets and employs same in its business operations.

4. The reasonable value of these assets is \$87,500.00.
5. Defendant Lake Region has not paid Plaintiff for such assets.
6. Plaintiff is entitled to interest upon the unpaid balance pursuant to RSMo § 408.020 from the date that Defendant Lake Region assumed control of the assets to date of judgment.
7. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation expenses in the prosecution of this action. Pursuant to RSMo §408.092, Plaintiff is entitled to recover such from the Defendant Lake Region.

WHEREFORE, Plaintiff requests judgment against the Defendant Lake Region, in the principal amount of \$87,500.00, for interest pursuant RSMo §408.020 from the date Defendant Lake Region assumed control of the Assets to date of judgment, for attorneys' fees and related litigation expenses pursuant to RSMo §408.092, for court costs, and for such other and further relief as this court deems just and proper.

COUNT V

COMES NOW Plaintiff, by and through its attorneys, and for its fifth cause of action against Defendant, Lake Region, states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II, paragraphs 1 through 8 of Count III and paragraphs 1 through 7 of Count IV as though fully set forth herein.
2. Subsequent to the date of the closing of the sale of stock of Lake Region, Plaintiff and Lake Region entered into an oral agreement whereby Plaintiff would design, construct and otherwise install the piping and other apparatus necessary for individual lot owners within the "Four

Seasons" development to hook into and otherwise use Defendant Lake Region's water and sewer systems. In consideration thereof Defendant Lake Region agreed to pay Plaintiff the sum of \$375.00 for each lot within Four Seasons which actually hooked into or otherwise connected to Lake Region's sewer and water system (hereinafter "road crossing fees").

3. That pursuant to such agreement, Plaintiff has performed all labor and supplied all material for which it agreed and further has installed all the piping and other apparatus necessary to allow third party to hook into Lake Region's sewer and water systems.
4. That since the date of the oral agreement, Defendant Lake Region has connected at least 218 lots to its systems using Plaintiff's material, labor and work and continues to connect lot purchasers to its systems at the present time and will continue to connect lots to its system in the future.
5. That Defendant Lake Region has not paid Plaintiff the road crossing fees due under the terms of the agreement.
6. Plaintiff has incurred a loss in the amount of \$81,750.00 as of the date of the filing of this petition as a result of Defendant's breach.
7. Plaintiff is entitled to interest upon the unpaid balance due and owing. Pursuant to RSMo §408.020, Plaintiff is entitled to interest on the road crossing fees from the date each individual customer was connected to the water, sewer to the date of judgment.
8. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation expenses in the prosecution of this action. Pursuant to RSMo §408.092, Plaintiff is entitled to recover such from the Defendant Lake Region.

WHEREFORE, Plaintiff prays that this court enter judgment against Defendant Lake Region in the principal amount of \$81,750.00, interest on the road

crossing fees from the date each individual customer was connected to such systems to the date of judgment, for attorneys' fees and related litigation expenses that have accrued and will continue to accrue to the date of judgment pursuant to RSMo §408.092, for court costs and for such other and further relief as this court deems just and proper.

COUNT VI

COMES NOW Plaintiff, by and through its attorneys, and for its sixth cause of action against Defendants, Lake Region, states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II, paragraphs 1 through 8 of Count III, paragraphs 1 through 7 of count IV and paragraphs 1 through 8 of Count V as though fully set forth herein.
2. From January of 2000 through June 6, 2003, at Defendant's request, Plaintiff performed excavation and rock drilling work to enable Defendant to connect two water wells and other apparatus necessary for the operation of water systems being operated by Lake Region.
3. Plaintiff charged a total of \$18,164.43 for its services.
4. Plaintiff's charges were fair and reasonable and the standard and usual charges for such work at the time such work was performed.
5. To date Defendants have not paid Plaintiff the reasonable value of its services.
6. Plaintiff is entitled to interest from the date of Plaintiff's performance of the excavation and rock drilling work to the date of judgment.
7. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation

expenses in the prosecution of this action. Pursuant to RSMo §408.092, Plaintiff is entitled to recover such from the Defendants.

WHEREFORE, Plaintiff requests judgment against Defendant Lake Region in the principal sum of \$87,500.00, for interest therein from the date of Plaintiff's performance to the date of judgment, for attorneys' fees and related litigation expenses that have accrued to the date of judgment pursuant to RSMo §408.092, for court costs and for such other and further relief as this court deems just and proper.

COUNT VII

COMES NOW Plaintiff, by and through its attorneys, and in the alternative to count VI and for its seventh cause of action against Defendant Lake Region states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II, paragraphs 1 through 8 of Count III, paragraphs 1 through 7 of Count IV, paragraphs 1 through 8 of Count V and paragraphs 1 through 7 of count VI as though fully set forth herein.
2. The reasonable value of Plaintiff's services is \$18,164.43.
3. Defendant Lake Region has not paid the \$18,164.43.
4. Pursuant to RSMo §408.020 Plaintiff is entitled to interest from the date of Plaintiff's performance of the excavation and rock drilling work to the date of judgment.
5. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation expenses in the prosecution of this action. Pursuant to RSMo §408.092, Plaintiff is entitled to recover such from the Defendants.

WHEREFORE, Plaintiff requests judgment against Defendants, jointly and severally, in the principal sum of \$18,164.43, interest thereon from the date of Plaintiff's performance to the date of judgment, for attorneys' fees and litigation expenses pursuant to RSMo §408.092, for court costs, and for such other and further relief as this court deems just and proper.

COUNT VIII

COMES NOW Plaintiff, by and through its attorneys, and for its eighth cause of action against Defendant Lake Region states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II, paragraphs 1 through 8 of Count III, paragraphs 1 through 7 of Count IV, paragraphs 1 through 8 of Count V, paragraphs 1 through 7 of Count VI and paragraphs 1 through 5 of Count VII as though fully set forth herein.
2. Between January of 2001 through June 6, 2003, at Defendant Lake Region's request, Plaintiff performed concrete work for the Defendant Lake Region when said Defendant was constructing a new sewerage treatment plant in the Shawnee Bend area of Camden County, Missouri.
3. Plaintiff charged a total of \$5,489.54 for its services.
4. Plaintiff's charges were fair and reasonable.
5. To date Defendant has not paid Plaintiff the reasonable value of its services.
6. Interest has accrued and will continue to accrue in the future upon the unpaid balance and pursuant to RSMo §408.020 Plaintiff is entitled to interest from the date of Plaintiff's performance of the concrete work to the date of judgment.

7. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation expenses in the prosecution of this action. Pursuant to RSMo §408.092, Plaintiff is entitled to recover such from the Defendants.

WHEREFORE, Plaintiff requests judgment against Defendant Lake Region in the principal sum of \$5,489.54, interest from the date of Plaintiff's performance to the date of judgment, for attorneys' fees and related litigation expenses pursuant to RSMo §408.092, for court costs, and for such other and further relief as this court deems just and proper.

COUNT IX

COMES NOW Plaintiff, by and through its attorneys, and in the alternative to Count VIII and for its ninth cause of action against Defendant Lake Region states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II, paragraphs 1 through 8 of Count III, paragraphs 1 through 7 of Count IV, paragraphs 1 through 8 of Count V, paragraphs 1 through 7 of Count VI, paragraphs 1 through 5 of Count VII and paragraphs 1 through 7 of Count VIII as though fully set forth herein.
2. At Defendants' request, Plaintiff performed concrete work for the Defendants.
3. The reasonable value of Plaintiff's services is \$5,489.54.
4. Defendants have not paid the \$5,489.54.
5. Interest has accrued and will continue to accrue in the future upon the unpaid balance and pursuant to RSMo §408.020 Plaintiff is entitled to interest from the date of Plaintiff's performance of the concrete work to the date of judgment.

6. Plaintiff has hired Curran & Sickal, Attorneys at Law, and has incurred, and will continue to incur in the future, attorneys' fees, court costs and litigation expenses in the prosecution of this action. Pursuant to RSMo § 408.092, Plaintiff is entitled to recover such from the Defendants.

WHEREFORE, Plaintiff requests judgment against Defendant Lake Region, in the principal sum of \$5,489.54, interest from the date of Plaintiff's performance to the date of judgment, for attorneys' fees and related litigation expenses pursuant to RSMo §408.092, for court costs and related litigation costs and for such other and further relief as this court deems just and proper.

COUNT X

COMES NOW Plaintiff and for its tenth cause of action against the Defendants states and alleges as follows:

1. Plaintiff restates and realleges the allegations contained in paragraphs 1 through 8 of the General Allegations, paragraphs 1 through 6 of Count I, paragraphs 1 through 4 of Count II, paragraphs 1 through 8 of Count III, paragraphs 1 through 7 of Count IV, paragraphs 1 through 8 of Count V, paragraphs 1 through 7 of Count VI, paragraphs 1 through 5 of Count VII and paragraphs 1 through 7 of Count VIII, and paragraphs 1 through 6 of Count IX as though fully set forth herein.
2. Plaintiff never assigned the right to collect said availability fees on lots sold subsequent to August 6, 1998 and not listed on Exhibit A to the Assignment.
3. That Defendants continue to collect the availability fees not itemized or included in the Assignment and despite Plaintiff's demands for Defendants to cease from such activity.
4. That Plaintiff is entitled to the availability fees collected on all lots sold by Four Season's subsequent to August 6, 1998 and not delineated on Exhibit A to the Assignment.

5. That Defendants possess the only financial records establishing the amounts paid and by whom.
6. That as a result of Defendants' actions, Plaintiff is losing income and revenue.
7. Plaintiff has no adequate remedy at law.
8. Unless restrained, Defendants continuing wrongful collection of availability fees will result in irreparable harm to Plaintiff in that Plaintiff will suffer a continued loss in business income and revenue and a consequent loss of profits and damage to its business operations and be unable to recoup same without the records

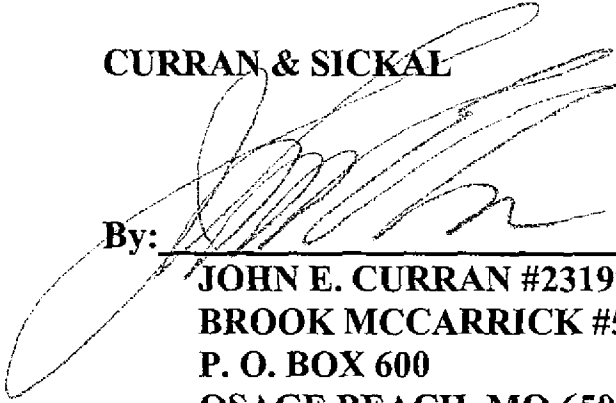
WHEREFORE, Plaintiff prays as follows:

1. For a temporary restraining order, restraining the Defendants, individually and jointly, and all agents, servants, employees and persons acting in concert therewith from:
 - A. Destroying, hiding, changing modifying or otherwise altering any and all memos, data bases, financial records, documents, or records of any type pertaining or referencing any availability fees collected or billed by Defendants since August 1, 1998; and,
 - B. Collecting or billing for any availability fees except those specifically listed on Exhibit A to the Assignment; and,
 - C. Doing any act or perform any procedure which would tend to interfere or defeat the purposes set forth in A and B immediately above.
2. After due notice and hearing, issue its preliminary injunction to the same effect; and,

3. After a full hearing upon due notice, issue its permanent injunction to the same effect; and,
4. For such other and further relief as this Court deem just and proper in the premises.

ASSIGNMENT

THIS ASSIGNMENT is made and entered into this 6 day of AUGUST, 1998, by and between FOUR SEASONS LAKESITES, INC., a Missouri corporation ("FSL") and FOUR SEASONS WATER & SEWER CO., a Missouri corporation ("W & S") (FSL and W & S collectively referred to as the "Assignor") and ROY and CINDY SLATES, husband and wife (collectively referred to as the "Assignee").

WITNESSETH:

WHEREAS, W & S, Four Seasons Group, Inc. and the Assignee have entered into a Stock Purchase Agreement as of even date herewith whereby Four Seasons Group, Inc. agrees to sell all of its stock in W & S to Assignee and to cause such other documents to be executed in favor of Assignee, including this Assignment.

NOW, THEREFORE, in consideration of the purchase price paid by the Assignee pursuant to the Stock Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and the Assignee agree as follows:

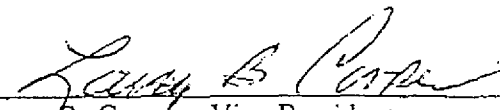
1. The Assignor does hereby transfer, assign, convey and deliver to the Assignee all of the Assignor's current and future rights, title and interest in and to any water and sewer service stand-by fees, availability fees and connection fees to which the Assignor may be entitled to receive, now or in the future, due to Assignor under the sale and purchase agreements described in the attached Exhibit "A", and the right to modify such fees as provided in said agreements; subject, however, to the Assignor's receipt of the consent of Assignor and, if necessary, the appropriate federal, state and local regulatory agency or agencies.

2. In the event the Stock Purchase Agreement shall terminate, or if Four Seasons Group, Inc. shall exercise its rights under Section 8 of the Stock Purchase Agreement to reacquire W & S, this Assignment shall terminate and the Assignee shall be required to refund or account for any billed, but unearned, fees received by it pursuant to this Assignment.

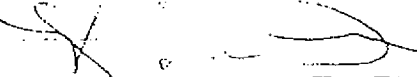
