Request:

2. Will the EDR be made available to multiple-occupancy buildings that otherwise qualify under the proposed EDR's applicability criteria?

(a) Does KCPL currently offer all electric rates under rate schedule GA to multiple-occupancy buildings?

(b) If the answer to Data Request 2(a) is affirmative, please state how many of the multiple-occupancy buildings served under rate schedule GA first received service from KCPL after May 6, 1978.

(c) If KCPL does provide service under rate schedule GA to multiple-occupancy buildings that first received service from KCPL after May 6, 1978, please reconcile the offering of such service with the applicability provisions of rate schedule GA which states that the rate schedule is: "applicable to a multiple-occupancy building only when the tenants or occupants of the building are furnished with electric service on a rent inclusion basis and service to such multiple-occupancy building was supplied continuously under this schedule from a date prior to May 6, 1978."

Response:

2(a) Yes. KCPL currently offers all electric rates under rate schedule GA to non-residential multiple-occupancy buildings.

2(b) Information is not readily available.

2(c) Please refer to KCPL's General Rules and Regulations Applying to Electric Service, Rule 5.03 which clarifies KCPL's ability to provide availability of rate schedule GA to non-residential customers.

Additionally, on or before January 6, 1989, KCPL will file with the Missouri Commission a revision to rate schedule GA incorporating the clarification reflected in Rule 5.03 directly in the applicability section of this schedule.
