### **Appendix G Summary**

As required by 10 CSR 80-2.020(2)(A)2.F., an application shall consist of "The names and addresses of all recorded owners of real property located either adjoining or within one thousand feet (1,000') of the (proposed) solid waste disposal area;".

A property ownership map of the recorded owners of real property adjoining or within 1,000 feet of the Ameren Missouri Labadie Energy Center proposed utility waste landfill site was obtained from the Franklin County Information Technology Department on December 3, 2012.

The attached figure, titled "Appendix G, Figure 1", was developed for illustrative purposes and shows the proposed UWL Permit Boundary and a boundary drawn 1,000 feet from the UWL Permit Boundary. The figure includes the approximate parcel boundaries drawn from the Franklin County property ownership map using the line symbol "—PB—".

The attached table, titled "Appendix G – Table 1" lists the recorded owners of real property (other than Union Electric dba Ameren Missouri) within 1,000 feet of the UWL Permit Boundary. A total of thirty (30) parcels have been identified on the table. The parcels have been generally sorted by Parcel ID. Subsequently, a unique 'Map ID Number' of 1 through 30 was assigned in the order the parcels appear in the table. This Map ID number was added to the attached figure to correlate the approximate parcel boundaries to the property ownership information in the table.
