## ORDER TO SHOW CAUSE

Issue Date: August 8, 2018

Effective Date: August 8, 2018

On January 22, 2013, William Wehrle filed a formal complaint against Spire Missouri, Inc., f/k/a Laclede Gas Company. The Commission dismissed the case by Order of June 11, 2014, citing Rule 4 CSR 240-2.116(2), which provides that “[c]ases may be dismissed for lack of prosecution if no action has occurred in the case for 90 days.” The Commission reopened the case on October 24, 2016, after Complainant filed a letter in EFIS denominated a “Response to Order Dismissing Complaint”. The Commission has issued further Orders requiring Complainant to specify what statute, rule, tariff, or Commission order the Complainant claims has been violated. Subsequently, Complainant has filed statements with the Commission. Nothing, however, has occurred in the case since October 19, 2017.

Because no action has occurred in the case for ninety days, the Commission will give Complainant an opportunity to show cause why this case should not be dismissed.

**THE COMMISSION ORDERS THAT:**

1. If Complainant, William Wehrle, does not want this case dismissed, he shall show cause why the Complaint should not be dismissed no later than August 20, 2018.
2. This order shall become effective immediately.
