On June 23, 2017, David Apted ("Mr. Apted") filed a complaint against Laclede Gas Company ("Laclede"). Laclede answered, stating that it had already performed the relief Complaint requested; thus, Laclede asks the Commission to dismiss the complaint. The Staff of the Commission ("Staff") filed a report that stated that Laclede has not violated its tariff or any law or Commission rule.

The Commission ordered Mr. Apted to state whether he wants to continue with the complaint. Mr. Apted timely responded.<sup>1</sup>
