# CLARIFICATION OF PREVIOUS ORDER REGARDING PROCEDURE AT HEARING

On November 19, 2021, the Commission issued an order regarding procedures to be followed at the joint hearing of these two cases. One provision of that order assigned numbers to the parties for exhibits that will be offered into evidence at the hearing, and directed each party to submit a list of their exhibits before the hearing. The Commission clarifies that the parties are to submit separate lists of exhibits in the electric and gas cases. However, the exhibit numbers should not overlap. So, for example, if the prefiled exhibits in the electric case are numbered 1-39, the list of prefiled exhibits in the gas case should start with number 40.
