ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: September 19, 2022 Effective Date: September 19, 2022 Union Electric Company d/b/a Ameren Missouri filed a tariff on August 1, 2022, to increase its rates for electric service. Metropolitan Congregations United (MCU) filed an application to intervene on September 6, 2022. MCU is a membership organization made up primarily of congregations of multiple faiths throughout the St. Louis region. More than ten days have passed since MCU applied to intervene and no party has responded to that application.¹

Commission Rule 20 CSR 4240-2.075(3) provides the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing MCU to participate in this rate case will serve the public interest. The Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

- 1. MCU's application to intervene is granted.
- 2. This order shall be effective when issued.
