

1 **I. INTRODUCTION**

2 **Q. Please state your name and business address.**

3 A. Amanda C. Conner, PO Box 2230, Jefferson City, Missouri 65102.

4 **Q. By whom are you employed and in what capacity?**

5 A. I am employed by the Missouri Office of the Public Counsel (“OPC”) as a Public Utility
6 Accountant.

7 **Q. On whose behalf are you testifying?**

8 A. I am testifying on behalf of the OPC.

9 **Q. What is the nature of your duties at the OPC?**

10 A. My duties include performing audits, reviews and examinations of the books and records of
11 public utilities operating within the state of Missouri.

12 **Q. Have you conducted a review of the books and records of Kansas City Power & Light
13 Company (“KCPL”) in this rate case?**

14 A. Yes, with the assistance of other members of the OPC.

15 **Q. Please describe your educational background.**

16 A. I earned a Bachelor of Science degree in Accounting from Columbia College in May 2012.

17 **Q. Please describe your related background.**

1 A. I began my employment with the OPC in February of 2016. Prior to my current position I
2 was employed by the Missouri Department of Revenue's ("DOR") General Counsel's
3 Office. My duties included accounting for trustee payments sent to DOR for Chapter 13 and
4 Chapter 7 bankruptcies for small business and personal taxes due.

5 **Q. Have you received specialized training related to public utility accounting and rate**
6 **making?**

7 A. Yes. I received regulatory and ratemaking training as an employee of the OPC. In addition
8 to this training, I attended the Utility Ratemaking Fundamentals course sponsored by
9 Brubaker Associate, Inc. (BAI) in the Spring of 2016. In the Fall of 2016 I attended the
10 NARUC Utility Rate School sponsored by Michigan State University.

11 **Q. Have you previously filed testimony before the Missouri Public Service Commission**
12 **("Commission" or "PSC")?**

13 A. Yes. I filed testimony in Case No. ER-2016-0023 The Empire District Electric Company's
14 recent rate case.

15 **Q. What is the purpose of your direct testimony?**

16 A. My testimony addresses OPC's rate making position on the following issues; 1) Rate Case
17 Expense, 2) Management Expense Charges, 3) Severance Payments

18 **RATE CASE EXPENSE**

19 **Q. What types of costs are included in KCPL's proposed rate case expense?**

20 A. As reflected in KCPL's workpaper CS-80, KCPL is seeking rate recovery for estimated rate
21 case expense of \$1,235,325 to be collected over three years or a normalized expense for this
22 rate case of \$411,775. Rate case expense consists primarily of legal and consulting fees.

1 **Q. Is rate case expense significantly different from other types of operating expenses?**

2 A. Yes. For example, KCPL has only an estimated amount for its rate case expense that will
3 vary based on how the case proceeds. Other operating expenses such as prepayments, while
4 subject to updates, will not change as a result of the process of the case. Additionally, a
5 portion of rate case expense is incurred solely for the benefit of the shareholders.

6 **Q. What is OPC's position on the appropriate allocation of rate case expense between**
7 **ratepayers and shareholders in a utility rate case?**

8 A. OPC supports a sharing of rate case expense because rate cases benefit both customers and
9 shareholders. While it must be specific to each rate case, the adjustment approach of
10 allocating rate case expense based on the ratio of the dollar revenue requirement ordered by
11 the Commission, to the dollar revenue requirement sought by a utility in its rate case
12 application is reasonable.

13 This adjustment approach was ordered by the Commission in its Report and Order in
14 KCPL's ER-2014-0370 rate case ("2014 Order"). Since that Commission Order was issued,
15 the Commission Staff ("Staff") has applied this rate case adjustment methodology in most,
16 if not all, of its rate case Cost of Service Reports. The approach used by the Commission in
17 its 2014 Order is the approach preferred by OPC in order to allocate the cost appropriately.

18 **Q. In its 2014 Order did the Commission develop a systematic and rational approach to**
19 **the allocation of rate case expense?**

20 A. Yes it did. Some dollar amount of rate case expenses may be "disallowed" based on
21 reasonableness or imprudence. However, expense disallowance was not the focus of the
22 Commission's position on rate case expense in its 2014 Order. The Commission's 2014
23 Order created a reasonable and prudent cost allocation methodology for this special type of
24 utility expense. The Commission did not address the issue of expense disallowance in its
25 2014 Order on rate case expense.

1 **MANAGEMENT EXPENSE CHARGES**

2 **Q. Does KCPL have a policy on the types of employee expenses that are reimbursable**
3 **by the utility?**

4 A. Yes. Provided to OPC in response to DR 1004 in the KCPL Greater Missouri Operations
5 Company (GMO) case number ER-2016-0156 is an overview of KCPL's company policy
6 "KCPL-E201 Reimbursement of Employee-Incurred Business Expenses." This KCPL
7 policy states that KCPL will reimburse employees for all reasonable, legitimate and
8 properly-documented expenses.

9 **Q. Does KCPL comply with its E201 employee-incurred business expense policies?**

10 A. No. My review of prior Staff and KCPL testimony on this issue convinces me that KCPL
11 has not complied with this policy since at least 2006, when it filed its first rate case in 20
12 years, Case No. ER-2006-0314. Over the past 10 years KCPL has continued to
13 reimburse non-qualifying employee expenses.

14 **Q. Is it your understanding that as a result of Staff testimony in past rate cases KCPL**
15 **has made changes in its management expense report charges?**

16 A. Yes, that is my understanding. GMO witness Ron Klote indicated in his rebuttal
17 testimony in GMO's 2016 rate case, No. ER-2016-0156, that KCPL has made some
18 changes to its accounting for management expenses. However, Mr. Klote did not indicate
19 that KCPL was making any changes to its E201 expense policies. OPC is hopeful that
20 any changes will lessen the risk of inappropriate expense report charges being reflected in
21 KCPL regulated books and records on a going-forward basis.

22 **Q. Does OPC believe that the changes made by KCPL are sufficient to protect**
23 **ratepayers from being charged inappropriate, excessive or imprudent management**
24 **expenses?**

1 A. No. OPC witness Charles Hyneman will address this concern in his direct testimony.

2 **Q. Were the management expense changes made by KCPL in effect during the test**
3 **year ended December 31, 2015 in this rate case?**

4 A. No. It is my understanding that these changes did not affect the expenses charged to
5 KCPL's 2015 general ledger, which is the basis of the test year cost of service in this rate
6 case.

7 **Q. Is OPC concerned about employee expenses charged to below-the-line non-**
8 **operating accounts as well as above-the-line operating accounts?**

9 A. Yes. In past rate cases and in this rate case, KCPL has expressed concern about
10 Commission ratemaking practices and the impact of regulatory lag on utility earnings.
11 While some of the most significant excessive KCPL management expense charges are
12 charged below-the-line, all of these expenses are paid with KCPL regulated utility
13 customer revenues. This means that excessive expense charges below-the-line will
14 decrease the realized regulated utility revenues. If these regulated utility customer
15 revenues were reflected in KCPL utility net income rather than reduced by below-the-line
16 expenses, KCPL's actual earned ROE would be higher than what is currently reports.

17 KCPL's earnings and returns on equity would be higher if these utility customer revenues
18 were not spent on excessive management expenses, even those charged below the line.
19 In effect, KCPL is intentionally or unintentionally reducing its own earned ROE by
20 continuing to engage in excessive and imprudent management expenditures, whether the
21 charges are recorded above- or below-the-line.

22 When KCPL charges excessive expense account charges "above-the-line", it is spending
23 money charged specifically to ratepayers as a cost of providing utility service. When
24 KCPL charges excessive management expense account charges "below-the-line" it is

1 spending “return money”, or “return on equity money” that should be reflected in
2 KCPL’s net income and provided to shareholders.

3 Both the shareholders and the ratepayers should have serious concerns with KCPL and
4 KCPL’s corporate culture as it relates to expense charges. Ratepayers and shareholders
5 are affected by KCPL and KCPL’s lack of compliance with its own expense account
6 policies, as well as its lack of internal controls over expense report charges. See
7 Schedule ACC-D-1 for a list of below-the-line charges by only 16 KCPL management
8 employees. Most of these charges are unrelated to either regulated or non-regulated
9 utility operations. However, excessive and inappropriate expenses charged to below-the-
10 line accounts reduce KCPL net income and deserve regulatory scrutiny especially when
11 KCPL has made its actual earnings an issue.

12 **Q. Did you and other OPC personnel conduct a review of KCPL’s management**
13 **expense charges?**

14 A. Yes. I conducted a comprehensive and detailed analysis of all or substantially all of
15 KCPL’s officer expenses charged in the December 31, 2015 test year general ledger.
16 OPC witness Charles Hyneman also participated in this review.

17 **Q. What were OPC’s findings from this review?**

18 A. OPC found that KCPL continues to reimburse excessive and imprudent employee
19 expense charges. Attached to this testimony is Schedule ACC-D-2, which is a sample of
20 excessive management employee expense charges reimbursed by KCPL.

21 **Q. Is OPC proposing an adjustment in an attempt to reduce the risk of excessive**
22 **employee expense charges being passed on to ratepayers in this rate case?**

23 A. Yes. Based on its review and the significance of the excessive cost by just one KCPL
24 employee, OPC is proposing an adjustment to account 921 in the amount of \$933,900.

1 This amount is designed to protect against all types of excessive employee expense
2 changes including, the excessive number of meal charges in the Kansas City area,
3 excessive meal charges, travel meals, hotel charges, drinks, and other charges for KCPL's
4 16 officers who incurred expenses in the test year in addition to KCPL's approximately
5 1084 other management employees.

6 **Q. How was this adjustment calculated?**

7 A. The adjustment is based on OPCs comprehensive and detailed review of several KCPL
8 employees' expense reports and recognizing the amount above what would be considered
9 reasonable expenses. OPC's adjustment reasonably quantifies excessive charges as well
10 as KCPL continued incurrence of business meals in the local Kansas City Missouri area.

11 OPC arrived at an amount per employee and multiplied that amount times the number of
12 management employees and then allocated that amount to KCPL using an average of
13 KCPL's corporate allocation factors (general allocator and Massachusetts formula).
14 Based on its review of KCPL's officer expense reports OPC estimates that on average,
15 the level of excessive charges per month is \$300. Recognizing that officer employees are
16 likely to incur more expenses than lower-level management employees, OPC assigned a
17 \$100 per month excessive charge for non-officer management employees. The allocation
18 is shown on "Adjustment" in Schedule ACC-D-2.

19 **SEVERANCE PAYMENTS**

20 **Q. Has KCPL charged employee severance payments to its test year income statement?**

21 A. Yes. KCPL's response to Staff Data Request No. 218 shows that in 2015 KCPL booked
22 severance costs in the test year to account 921 of \$24,613 and account 557 of \$58,503.
23 OPC is proposing an adjustment to remove these charges from KCPL's test year income
24 statement.

1 **Q. Does the Commission typically allow rate recovery of utility severance payments?**

2 A. No. The Commission typically does not allow rate recovery of utility severance
3 payments.

4 **Q. Are severance payments a type of utility cost that should be included in a utility's**
5 **cost of service?**

6 A. No, for several reasons. The primary reason is that severance payments are often
7 recovered by the utility through regulatory lag. Regulatory lag usually allows a utility to
8 not only recover the amount of severance payments, but in some cases recover two and
9 three times the amount of the severance payment. This is the result of a utility recovering
10 the salaries and benefits, after the employees have been severed, in rates until rates are
11 changed in the next utility rate case.

12 An additional reason why the cost of utility severance agreements should not be included
13 in cost of service is that the agreements required to be signed by the severed employee
14 contains language designed to protect utility officers and shareholders from potential
15 litigation and embarrassment. Utility severance agreements typically require the severed
16 employee to waive and release any legal claims the employee may have against the utility
17 for any reason and prohibits the employee from making any disparaging or critical
18 statements of any nature whatsoever about the utility. The cost of securing these types of
19 commitments from severed employees should be borne by shareholders and not
20 ratepayers.

21 **Q. Does this conclude your direct testimony?**

22 A. Yes, it does.
