ORDER DIRECTING STAFF RECOMMENDATION ABOUT EMPIRE'S COMPLIANCE TARIFF FILING AND SETTING A DEADLINE FOR OTHER RESPONSES

Issue Date: June 6, 2022

Effective Date: June 6, 2022

On April 6, 2022, the Commission issued its Report and Order authorizing The Empire District Electric Company (Empire) to file tariff sheets in compliance with that order. Empire's initial compliance tariff sheets became effective on June 1, 2022.

On June 2, 2022, Empire filed tariff revision Tariff No. YE-2022-0270. Empire states that these two compliance tariff sheets were inadvertently not included in Empire's previous compliance filing. The tariff sheets bear an effective date of July 2, 2022. The Commission will direct its Staff to file a recommendation informing the Commission of whether these tariff sheets comply with the Commission's Report and Order. The Commission will also set a deadline for any other responses to Empire's compliance filing.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation about Empire's compliance tariff sheets no later than June 15, 2022.
2. Any other response to Empire's compliance tariff sheets is due no later than June 15, 2022.

3. This order shall be effective when issued.
