- SUBJECT. Staff Report and Recommendation Regarding the Union Electric Company d/b/a AmerenUE ISRS Rate Compliance Filing and Motion for Expedited Treatment in Regards to Infrastructure System Replacement Surcharge (ISRS) Increase
- DATE August 25, 2009

On August 12, 2009, the Commission issued its order approving the Commission Staff's recommendation regarding the appropriate Infrastructure System Replacement Surcharge (ISRS) rates for Union Electric Company d/b/a AmerenUE (AmerenUE or Company). Staff's memo recommended that the Commission reject AmerenUE's initially-filed rates, and contained a schedule of lower ISRS rates that were considered appropriate.

On August 13, 2009 AmerenUE filed a tariff sheet with the Missouri Public Service Commission (Commission) with a proposed effective date of September 1, 2009. In addition, AmerenUE filed a MOTION FOR EXPEDITED TREATMENT (Motion) relating to this filing on the same day. The Motion requested an effective date of September 1, 2009.

On August 14, 2009, the Commission issued an order that set date for responses to AmerenUE's MOTION FOR EXPEDITED TREATMENT – that date being August 21, 2009.

The Staff has reviewed AmerenUE's tariff sheet and AmerenUE's Motion. The Staff's analysis indicates that the tariff sheet was filed in compliance with the Commission's Order in this case. Staff has no objection to the expedited effective date of September 1, 2009.

The Staff has verified that AmerenUE has filed its annual report and is not delinquent on any assessment. The Staff has reviewed this filing and is not aware of any issue currently pending before the Commission that affects, or is affected by this filing.

Therefore, the Staff recommends that the following tariff sheet, as filed on August 13, 2009, be allowed to go into effect on September 1, 2009, as requested by AmerenUE.
