ORDER OF RULEMAKING

By the authority vested in the Missouri Public Service Commission under section 700.460, RSMo 2000, the Commission adopts a rule as follows:

4 CSR 240-121.180 Monthly Report Requirement for Registered Manufactured Home Dealers is amended.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on October 16, 2000 (25 MoReg 2523). No changes have been made to the text of the proposed amendment, so it is not reprinted here. This proposed amendment becomes effective thirty days after publication in the *Code of State Regulations*.


