Union Electric Company d/b/a Ameren Missouri has filed its 2017 Integrated Resource Plan (IRP), as required by the Commission's Electric Utility Resource Planning Rule, 4 CSR 240-22. As required by 4 CSR 240-22.080(7), the Commission's Staff reviewed Ameren Missouri's IRP filing and filed a report on February 28, 2018. Similarly, as permitted by 4 CSR 240-22.080(8), Renew Missouri Advocates, Wind on the Wires, the Division of Energy, Sierra Club, the Natural Resources Defense Council, and the National Association for the Advancement of Colored People (NAACP) filed comments concerning Ameren Missouri's IRP filing.

On April 30, Ameren Missouri and the other parties made a joint filling explaining how they have been able to resolve some of the deficiencies and concerns raised about the IRP filing. On the same date, Ameren Missouri filed its response to the alleged deficiencies and concerns that have not been resolved.

Before determining how to proceed, the Commission will give the parties an opportunity to reply to Ameren Missouri's response.

1. Any party wishing to reply to Ameren Missouri's response to alleged deficiencies and concerns shall do so no later than May 30, 2018.
