## ORDER GRANTING STAFF ADDITIONAL TIME TO FILE A RECOMMENDATION OR A STIPULATION AND AGREEMENT

On September 1, 2017, Union Electric Company d/b/a Ameren Missouri filed its application for acceptance of its filing of cost estimates for Callaway Energy Center decommissioning. The Commission directed its Staff to file a recommendation regarding that application by December 1. On that date, Staff filed a request for additional time, explaining that it is negotiating with Ameren Missouri to reach a stipulation and agreement to resolve all pending matters in this case. Staff asks to be allowed until December 29 to file such stipulation and agreement.

The Commission will grant Staff's request.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file either a stipulation and agreement or a recommendation regarding Union Electric Company d/b/a Ameren Missouri's Application for Acceptance of Decommissioning Costs no later than December 29, 2017.

2. This order shall be effective when issued.
