On December 1, 2017, the Staff of the Missouri Public Service Commission filed its Notice of Start of First MEEIA Prudence Review of Cycle 2 Energy Efficiency Programs of Ameren Missouri. The Missouri Department of Economic Development, Division of Energy applied to intervene on December 7, 2017. More than ten days have passed since that application to intervene was filed and no one has responded to the application.

The Commission finds that allowing the Division of Energy to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application to intervene.

1. The application to intervene of the Missouri Department of Economic Development, Division of Energy is granted.
